HIGHLIGHTS

We changed our name to UConnectCare in the fall of 2023.

UConnectCare was named a Best Company to work for in New York for the 6th year in a row.

Trends on our Perception of Care surveys provided to patients included statements like, "staff are caring, helpful, always willing to listen," and "staff are committed to the patients."

Atwater Community Residence transitioned in September 2023 to an 820 program. This allows us to provide three different elements of care: stabilization, reintegration and rehabilitation.

Through the NYS Opioid Settlement Funds award, we received funding for renovations, activities, and events that support the recovery community at The Recovery Station.

Substance Abuse and Mental Health Services Administration (SAMHSA) awarded us a federal Targeted Capacity Expansion Special Projects grant in the amount of \$375,000 to provide harm reduction services in the community.

Health Services and Resource Administration (HRSA) awarded us a federal Rural Communities Opioid Response Program (RCORP) Neonatal Abstinence Syndrome II grant in the amount of \$498,848 to provide our Healthy Moms/Healthy Babies program to pregnant and postpartum women.

NYS Department of Health awarded us a Statewide Health Care Facility System Transformation grant in the amount of \$985,250 to improve our building capacity in our integrated outpatient treatment program in Batavia.

The Recovery Station increased support groups in 2023. Each week we host LGBTQ+, spirituality, and various women's and men's support groups. AA and NA groups use our facilities weekly.
